

## Application for SCAL COVID-19 Fund

The SCAL COVID-19 Fund launched on 8 May 2020 is the latest initiative by the Singapore Contractors Association Ltd (SCAL) to help the construction sector brave the challenges faced in the light of COVID-19. SCAL aims to raise more than \$1 million through contributions from SCAL members, the Building and Construction Authority, and by working with Enterprise Singapore to tap on the SG Together Enhancing Enterprise Resilience (STEER) programme.

This Fund will specifically help small and medium enterprises (SMEs) by providing them with a one-off relief to ease their financial difficulties, particularly during this Circuit Breaker period.

The relief support under the SCAL COVID-19 Fund is as detailed below:

- a. Company eligibility
  - SCAL member (Ordinary/Associate/Trade) or registered trade subcontractor as at 1 April 2020, and
  - Company's group annual sales turnover is not more than S\$100 million OR has an employment size of not more than 200 workers, and
  - Firm is assessed to be in financial hardship
- b. Eligible firms can receive a one-time support capped at \$3,000 based on the following factors:
  - \$300 for each eligible Singaporean/PR employee with household income not more than \$5,000
  - \$100 each for a foreign employee and 1 dependent under Stay-Home Notice (SHN)
